The Panic Bar Models include an optional Key Override Function, which can override the access control device in the event of a power failure or malfunction.

Interchangeable - You can install the LockOne™ Lock Series in your facility to maintain a consistent look as the appearance of the exterior trim has not changed.

Retrofittable - Simply remove the existing LKM7000 and attach our retrofit fixture, modify a few existing holes then install either the Type III or IV model (sold separately).

Key Override Option - A separate module is no longer necessary for this option. Key Override is standard on all LLKM10K models. However, it is optional to utilize, so it can be added with little effort at a later date if necessary. Key Override allows a key to "override" the access control device only. It will not override the combination lock. This capability is particularly important during the event of power outage, failure or malfunction of an access control device, or an emergency that requires expedited entry.











Exterior Trim with Fire Rated Key Override Installed


